The presentation on New Jersey's Water Infrastructure precedes the opportunity for the public to offer comment on standards of performance for asset management and means to assure sufficient funding for such projects. The hearing will be held from 9:00 a.m. - 1:00 p.m. at the NJ Department of Environmental Protection, Public Hearing Room, 401 East State Street in Trenton, NJ.
